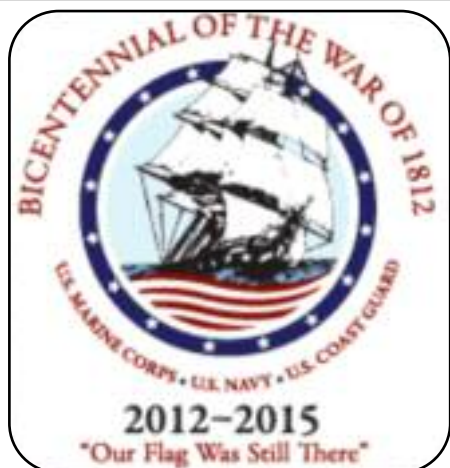

I don't know about you slackers – but today (Friday, May 10th,) I had my first boat ride of the season. Many of you know that David Doyle is one of our chapter members who champions outboards – especially Switzcraft boats. David recently managed to swap his 1955 Lightning for a 1956 Shooting Star which is one year older than his red and white Shooting Star. This one is blue and white – and while it is an older restoration, he knew the boat and when it came up on eBay went on a quest to add it to his stable. His wife, Paula thought it would be fitting if he sold one before he bought another one. So he did. Of course it is powered by a nice Mercury Mark 55. David claims this boat will be on his boat lift this summer and will be used.

So today was the water trial and because I've a hitch on my van and have been known to climb on a raft and shoot pictures of him as he screams by with his rooster tails flying – I was invited along. It was a beautiful day for this with temperatures in the low 70's and rather stiff southwest breezes. We backed the new (old) boat in the water and tested for water circulation in the Merc, and off we went. Out past the "no wake" buoys, David dropped the throttle forward and we planed off quickly – wind in our faces and hair (what little is left in my case) flying. Boy did it feel fine to be on the water. David found a raft to drop me on and I discovered how another year has attacked my agility climbing out of the boat. You must all be sure to ask him the next time you see him what happened next as he tried to motor back away from the raft. I'll let him tell the story. You may have to buy him a drink.

But, it means for me another boating season in this state of multiple climates is underway. And, I'm hoping that a number of you have already had your first boat ride as this issue hits your mailboxes. I know this morning put me back in a boating frame of mind as soon as we were flying across the water. Get those boats out there and use them. And if your boat isn't ready for the water yet – call another member and invite yourself along on their first, or next, ride. Most of us welcome a chance to show off our boats on the water and underway.

Our chapter had a great meeting on April 20th at the Delafield Brewhaus. It was really good to see everyone after a long stretch since the January meeting and the Greater Milwaukee Boat Show. We had an excellent presentation by Kimm Stablefeldt on his experiences of diving ship wrecks at the bottom of the great lakes. Would you believe there are somewhere between 8 and 10 thousand wrecks down there. It was especially interesting to me how regulated this activity is. Permits must be issued and reports made on the activity a group takes each time they dive a wreck. The goal is to photograph and draw the wrecks as they exist as accurately as possible. This process can easily take up to three years once a wreck is located.

Our chapter's application for 501(c)(3) status continues to be under review by the IRS. We have been asked to provide additional information for a second time and I am in the process of putting that response together. At our board meeting on April 20th, we passed a resolution adopting language for our by-laws that was suggested by the IRS that will help us conform to their guidelines. That resolution has currently been submitted to the Secretary of State of Wisconsin for inclusion and once it is stamped will become a part of our corporate structure.

Finally, after floundering around for a while trying to get our web-site back up and running, chapter member Matt Byrne has stepped up and offered his services to accomplish the task. Matt currently manages the Blackhawk chapter web-site and currently also is helping the Chris Craft Antique Boat Club with their web-site management. Over the next week or two we will be getting information, boat show registration forms, photos and other organizational updates to Matt so that our web site will be current and up to date. As time goes on we hope to have Matt redesign some of the format and accessibility options. Kudos to Matt for offering his services at no charge to the chapter.

Our chapter has a lot going on this boating season. Eagle River, Karl John's outing on Okauchee, the Madison and Pewaukee boats shows, The Big Cedar outing at Timmers, The Bicentennial Celebration of the War of 1812 at Discovery World and other events that you will find listed in this newsletter. Let's get the boats out and enjoy what little time Wisconsin allows us in the water.

Gayle Ritter has come back to handle the public relations calls that are so necessary to welcome new members to the chapter. Peter will continue to handle the IT part of the membership flow from ACBS.

One final note; check out the story and photos on page 17 of the latest issue of the "Rudder" on Lance Eherke and his grandchildren and their project boat "Lily". If you were able to attend the Greater Milwaukee Boat Show at State Fair Park, you may remember Lance's display.

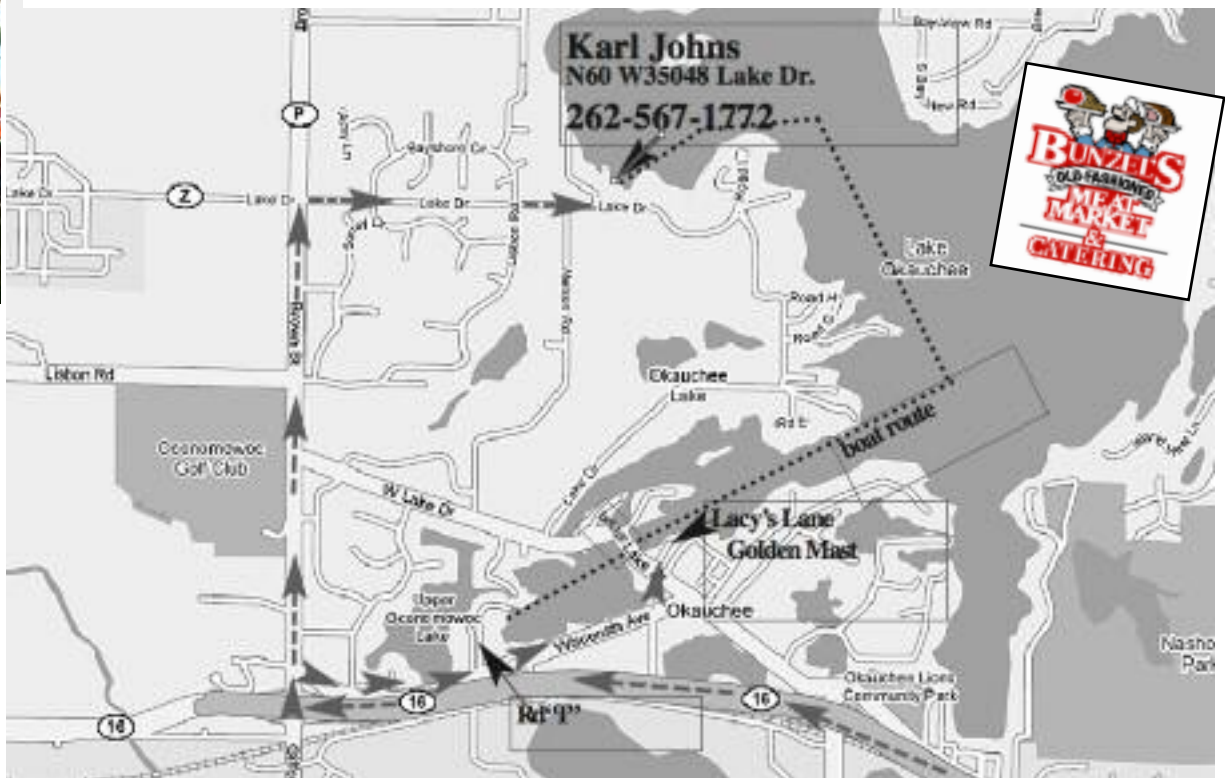

The meeting was held at the Delafield Brewhaus in Delafield, WI. After dinner, **Commodore Jack Schneiberg** called the meeting to order at 8:07 PM. Members who were attending for the first time introduced themselves, Brian Berg & Diane Tryba from Wausau and Don and Louanne Severson from Elkhorn.

Treasurer's Report: Mary Willis reported that the current balance in our checking account is \$2,428.38 as of 4/20/12. **Jay Wagner** made a motion to approve the Treasurer's report, and **Bob Stoltz** seconded. Motion carried.

Review of Past Minutes: The minutes from the last meeting at the Brookfield Old Country Buffet on January 8, 2012 were approved following a motion made by **Karl Johns** and seconded by **Helen Petran**.

501(c)(3) Status Update: Commodore Jack reported that in March, the IRS informed him that they need more information for finalizing our 501(c)(3) status. The board met immediately before the general meeting and voted on accepting IRS suggested wording for an addendum to be filed with the State to our bylaws already filed, regarding: that we are organized strictly for charitable & educational purposes, that net earnings will not be distributed to members or officers except for compensation for services, that we will not carry on propaganda or attempt to influence legislation, and upon dissolution of the organization, assets will be distributed according to section 501(c)3 of the IRS code. Jack opened the floor to questions. **Andy McCormick** asked if the whole idea of attaining that status was for tax deductibility. Jack responded that we took a proactive stance to obtain the most desirable status. Not all boat clubs are 501(c)(3). It will greatly simplify our tax reporting in the future, and we will be eligible to apply for raffle permits. No action was needed from the general membership as the board acted.

Finding Shipwrecks in The Great Lakes

On April 20, 2012, Kimm Stabelfeldt an Amateur Underwater Archaeologist presented a program on Amateur Archeological of Shipwrecks in the Great Lakes to The Glacier Lakes Chapter of ACBS. Kimm works in conjunction with a number of Historical Societies and the state Wisconsin Historical Society (WHS) planning and executing dives on Great Lakes Shipwrecks. Kimm's team of divers is all Amateur's and volunteers. The concept of using volunteers helps train divers to do this work and helps the State WHS to do more projects because more divers are trained to do this kind of specialized work. The overall goal Stabelfeldt said is "Preservation through Documentation". This type of project involves no artifact recovery or deck/hull recovery. The only purpose is the recording of the vessel by means of drawings, plans, and photographs and filming the wreck for preservation. Kimm is the Dive Officer and takes care of all logistics, training and provided all the tools required to do the learning and work.

Kimm's presentation provided a visual look at the work being done on the bottom of the Great Lakes on wrecks from the 1830's to present wrecks. His detailed power point presentation demonstrated the work of setting up a wreck site, the drawings done by armatures during a field study and the final results that are used in different Historical Society publications. Following each dive a project report is provided and annually reports are also provided on the success of each project and progress of those running year to year. The projects are funded via donations, Project T-Shirt/hat sales, and sale of the field reports to the public.

According to Stabelfeldt the methodology concept is to establish a datum line down the center of the wreckage along the keelson using a large tape measure. By developing small manageable sections, individual divers can begin recording in plain view the structure and artifacts within each section. The success of this methodology involves the use of photographs and video. As actual time on the site can be limited due to schedule, weather and budget, much of the survey must actually be completed back on land. Images of the wreck, when properly documented can play a large part in providing accurate data from the site. He said that "then the recording teams can focus their time on defining the big picture, overall sizes, orientation and distribution of artifacts. Photographic images can be used to fill in the detail."

Fire Destroys Rare Antique Wooden Boats Oneida Boat Works WE CAN HELP!

HARSHAW - On Sunday April 29, a fire in the woods behind Tom Jordan's shop got out of control and totaled The Oneida Boat Works business. Tom said luckily the house was spared even though it suffered some siding damage. Because his shop is out quite a ways, it took the fire department about 20 minutes to get to the fire scene.

Out of 10 boats inside, two were saved from the fire. "The building was totally engulfed when the fire department arrived on the scene. The woods behind the building was on fire according to the story.

According to the news article, between the boats lost, the custom machinery, and the workshop itself, Jordan estimates the damage at around \$300,000.

Tom lost a customer's antique boat, antique canoes, antique outboard motors,



advertising signs and other classic nautical paraphernalia that would take a lifetime to collect. The Insurance company is denying coverage. Unfortunately, an attorney was hired. Mary and I decided to make a trip to Florida on Thursday March 8th. We hadn't been to the Mount Dora Boat Show since it had moved to Tavares about five years ago. The plan was to do a side trip to **The Antique Boat Center** in Cincinnati, Ohio. ACBS was doing a symposium and workshop sessions. We would then drive down to Naples and work our way up to Tavares. We visited friends in Naples, Bonita Springs, Fort Myers, and Sarasota. Our final stop would be in Tavares, Florida for the Sunnyland ACBS Chapter Boat Show.

ACBS SYMPOSIUM-WORKSHOP SESSIONS

Saturday March 10-11, 2012 Lou Rauh, CEO, Antique Boat Center and **Dennis Ryan President**, Antique Boat Center welcomed the group of 35 plus classic boat aficionados Saturday morning March 10 at The Antique Boat Center in Cincinnati, Ohio. This symposium as well as other symposium/workshops is being coordinated by The Antique & Classic Boat Society at various locations in 2012. **Dick Warner**, past ACBS President has been scheduling, coordinating and helping to conduct these educational gatherings. Between March and May, six ACBS sponsored symposium workshops will have been conducted.

The Antique Boat Center class instructors included: **Joel Terbrueggen**, Shop Manager; **Frank Jones**, restoration/mechanical expert; **Bryan Conroy** and **Tim Frey**, restoration specialists; **Jeremy Bragg** and **Brian Keen**, mechanical technicians.

Other Antique Boat Center staff members on hand included: **Jim Barach**, Sale Manager; **Matt Balogh**, sales associate; **Angie Wilkins** CFO, Antique Boat Center and **Melody Rogers**, website-networking.

Attendees were divided into two groups. Each session was four hours and then the groups were switched after lunch.

SATURDAY-GROUP A: Laminating new decks was part of this session. This is an alternative planking technique to eliminate seam separation. Apparently this procedure has been done for about ten years. The workshop session included the removal of bungs without damaging the planks. It included the use of epoxy to repair split planks, removal of deck seam material and broken screws, fairing hull sides, power sanding as well as hand sanding. Attendees were shown what grits of sand paper are used for each step.

SATURDAY-GROUP B: This session began with bleaching the wood followed by staining and sealing. Techniques were shown on how to match the stain of new planks with older planks. Also covered was the repairing of common

damages to the varnish and wood damage caused by the sun and human error. Examples are crazing of varnish, splits in the deck and deep gouges in the side planks were shown. Filling in the deck seams, techniques used in varnishing and painting the deck seams were all part of this session.

SUNDAY: This session started with general engine maintenance. It was a How to prevent problems so our old marine engines will provide us with many hours of boating pleasure. The last session covered, "How to inspect a boat for purchase." This session was divided into 2 groups whereby each group inspected a boat for its hull and mechanical soundness.

It was a very informative weekend in that I don't personally do restorations or do engine maintenance. It was hopefully an opportunity to prove **Karl Johns** wrong in a discussion we had regarding the spacing of the bottom planks on a wood boat restoration project. Unfortunately, I was wrong. **Karl, MEA CULPA, MEA CULPA.** Do you think he will see this?

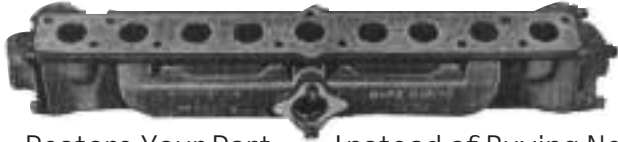

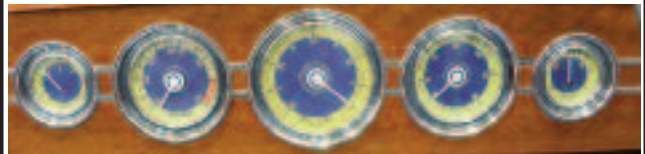

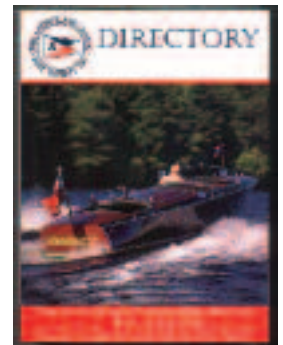
